Allocasuarina crassa cape pillar sheoak

Group: Magnoliophyta (flowering plants), Magnoliopsida (dicots), Casuarinales, Casuarinaceae

Status: *Threatened Species Protection Act 1995*: rare
Environment Protection and Biodiversity Conservation Act 1999: Not listed

Endemic Status: Found only in Tasmania

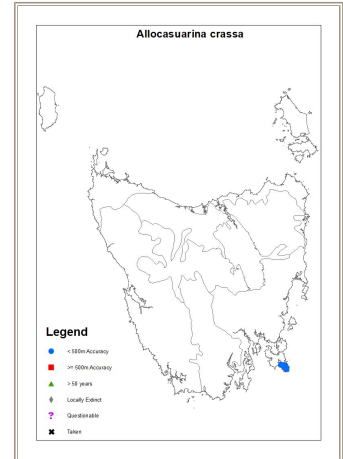

- This shrub can be identified at any time of the year using vegetative characteristics.
- Allocasuarina crassa* is found on dolerite soils and can be encountered in both damp eucalypt forest and cliff-top heathland and scrub. It may form almost monotypic scrubs on the Cape Pillar plateau given a prolonged fire-free period.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
