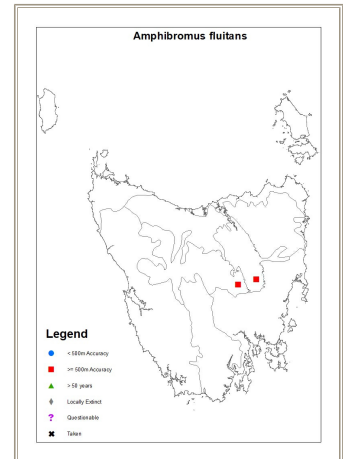

- On the mainland, this grass flowers and fruits mainly between November and March. Mature inflorescences are required for identification. The 2 Tasmanian records are from January and February. The species may have been introduced to Tasmania.
- This species grows mostly in permanent swamps but inhabits both natural and man-made water-bodies, including swamps, lagoons, billabongs and dams, and in roadside ditches. The species needs wetlands which are at least moderately fertile and which have some bare ground, conditions which are produced by seasonally-fluctuating water levels.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
