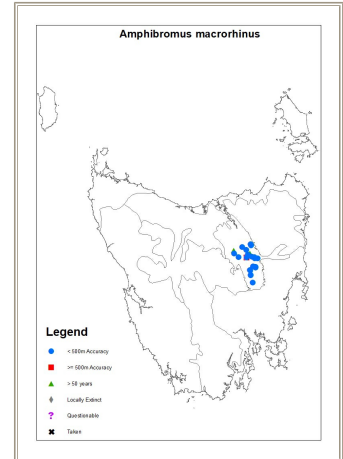

- Flowering of this grass is from October to December (Flora of Victoria). Most herbarium specimens have been collected between December and early January. Mature inflorescences are required for identification.
- In Tasmania, *Amphibromus macrorhinus* inhabits water holes and low lying wet areas in the Midlands region.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
