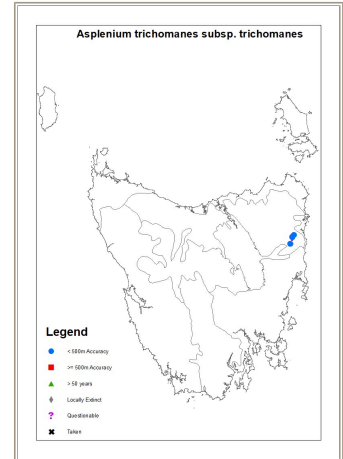

- This fern can be identified using vegetative characteristics. The species dies down in drysummers at some sites.
- In Tasmania, the species occurs on exposed dolerite outcrops in dry sclerophyll forest in areas of low rainfall between 450 and 680 m above sea level. Plants grow on northwest to northeast facing outcrops in the shallow soil of crevices or sloping rock platforms.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
