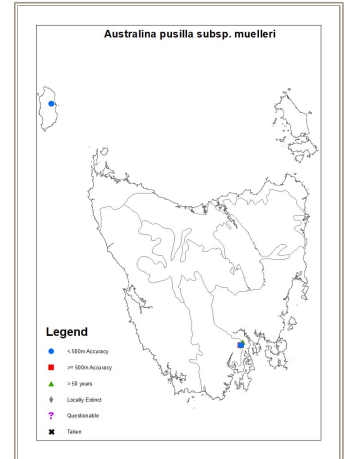

- Flowering of this perennial herb is from November to February. Herbarium specimens have been collected from late October to late November, though the species can be identified at any time of the year from vegetative characteristics.
- In Tasmania, the species is known from the southern flanks of Mount Wellington in deeply shaded gullies in wet eucalypt forest, and from King Island where it grows in association with *Australina pusilla ssp. pusilla* along stream flats in blackwood swamp forest.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
