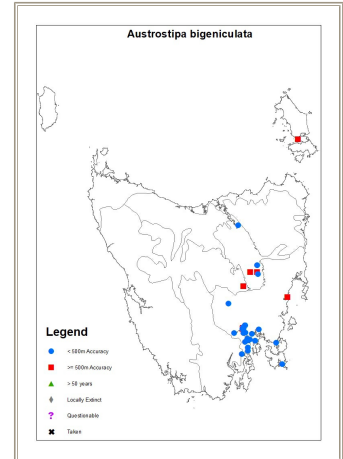

- Flowering of this grass in Australia is from November to January. Most herbarium specimens have been collected in December and most observations have extended through to early April. Mature inflorescences are required for identification. Flower spike remnants may allow identification at other times of the year. Most occurrences show characteristics of *Carex inyx* causing confusion with identification.
- In Tasmania the species is found mainly in the southeast and Midlands in open woodlands and grasslands, where it is often associated with *Austrostipa nodosa*.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
