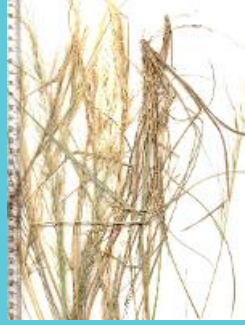
*Austrostipa blackii* crested speargrass

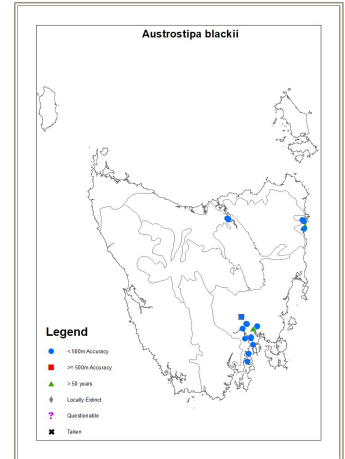

- Flowering of this grass is predominantly from November to January (Flora of Victoria). Most herbarium specimens have been collected from late December to March, the recommended timing for surveys, though some observations have been made at other times of the year, presumably identified from remnant flower spikes. Mature inflorescences are required for identification. Intergradation with other species may confuse identification.
- In Tasmania, *Austrostipa blackii* occurs in open woodlands up to an altitude of 100 metres.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
