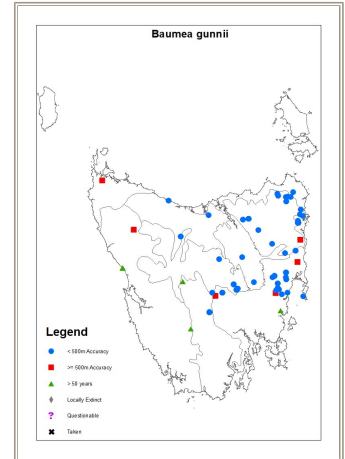

- Flowering of this perennial sedge is from spring to summer (Flora of Victoria). Herbarium specimens have been collected throughout the year.
- In Tasmania, *Baumea gunnii* inhabits wet moors, creeks and riverbanks throughout the State.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
