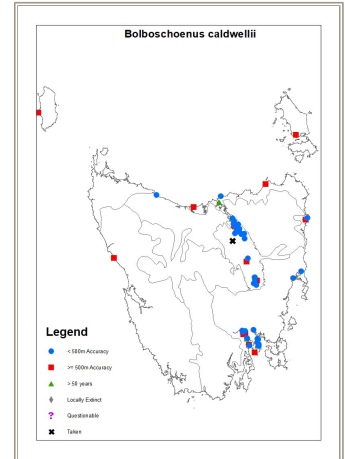

- Flowering of this perennial sedge is throughout the year but mainly in October to April. Inflorescences are required for identification. Most herbarium specimens have been collected from November to March.
- In Tasmania, *Bolboschoenus caldwellii* is widespread in shallow, standing, sometimes brackish water, rooted in heavy black mud.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
