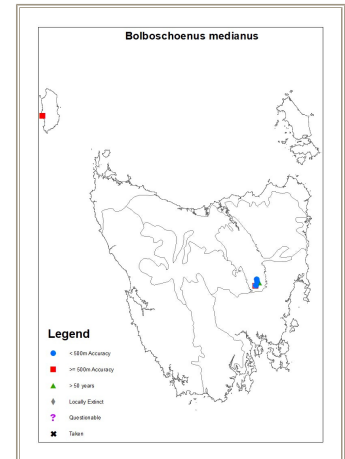

- Most observations of this perennial sedge have been made from November to mid February. Inflorescences are required for identification, though plants of this species do not flower regularly.
- In Tasmania, *Bolboschoenus medianus* inhabits the margins of lagoons where it is often rooted in heavy black mud.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
