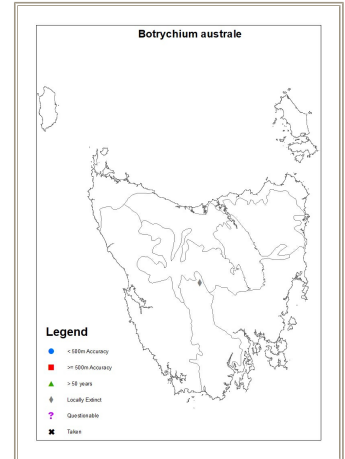

- This sparse fern can be identified at any time of the year from its branched fronds, one of which is vegetative.
- Botrychium australe* is presumed extinct in Tasmania. On mainland Australia it is known from a wide range of habitats from lowland forest and scrubland to subalpine grassland. It requires adequate moisture and can be found in grassy woodland, well-drained plains, near streams in subalpine regions and in mossy soils.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
