Group: Magnoliophyta (flowering plants), Magnoliopsida (dicots), Ericales, Ericaceae

Status: *Threatened Species Protection Act 1995*: rare

Endemic: Found in Tasmania and elsewhere

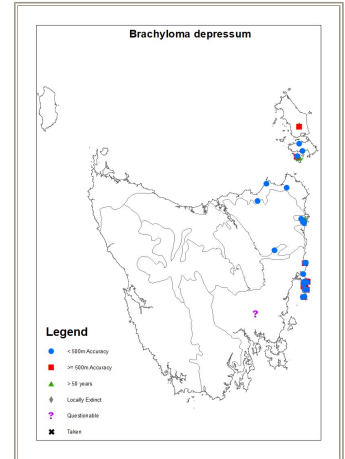

- Flowering of this shrub is from August to December (Flora of Victoria). Most herbarium specimens have been collected from September to December, though the species can be identified at other times of the year from its leaves.
- In Tasmania, *Brachyloma depressum* is found in shrubby heathland amongst granite boulders/sheets or on granite soils.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
