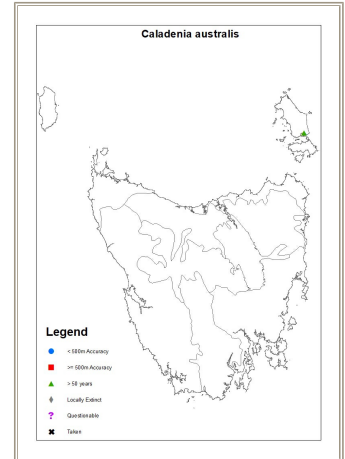

- Flowers are required for the identification of this ground orchid which dies back to subterranean tubers after flowering. Flowering period on mainland Australia is September to November. Known only from one collection in Tasmania (9 November 1968, Flinders Island). Late October to early November is likely to be a good time to search for the species here.
- In Victoria, *Caladenia australis* is a widespread species of southern coastal and sub-coastal heathy woodlands and coastal scrubs on sandy loams below 50 m elevation. There is no detailed information on the Flinders Island collection but it is probably from lowland coastal heathy scrub/woodland.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
