Caladenia cardiochila heartlip spider-orchid

Group: Magnoliophyta (flowering plants), Liliopsida (monocots), Orchidales, Orchidaceae

Status: *Threatened Species Protection Act 1995:* extinct

Endemic: Found in Tasmania and elsewhere

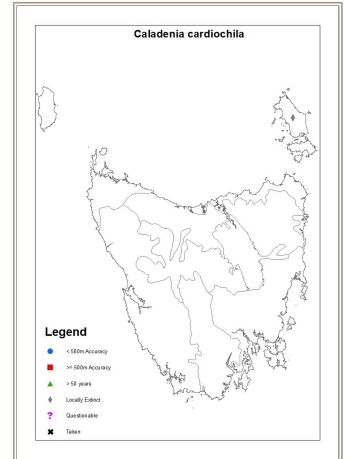

- Flowers are required for the identification of this ground orchid which dies back to subterranean tubers after flowering. Flowering period on mainland Australia is August to November but collected in Tasmania only once (from somewhere on Flinders Island) in October 1947.
- On the mainland, *Caladenia cardiochila* is a widespread and often common species found in a wide range of forested and shrubby habitats on well-drained soils. There is no detailed information on the Flinders Island collection.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
