Endemic Found only in Tasmania



- Flowers are required for the identification of this ground orchid which dies back to subterranean tubers after flowering. Flowering plants have been seen from mid October to early November in the northern Midlands and mid December in the Lilydale area, with old records from the 1800s in early January from Circular Head where they are now extinct.
- The species occurs in lowland open eucalypt forest and woodland. The potential habitat of this species is poorly understood.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
