

## SPECIES MANAGEMENT PROFILE

*Calystegia sepium* subsp. *sepium* swamp bindweed

**Group:** Magnoliophyta (flowering plants), Magnoliopsida (dicots), Solanales, Convolvulaceae

**Status:** *Threatened Species Protection Act 1995*: rare  
*Environment Protection and Biodiversity Conservation Act 1999*: Not listed

**Endemic Status:** Found in Tasmania and elsewhere

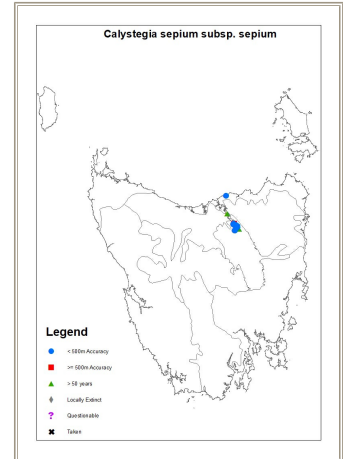

- While peak flowering occurs over spring and summer, flowers are present on this perennial twining or prostrate vine all year, and as the plant is conspicuous, surveys for it can be undertaken at any time of year. This species is a known coloniser of waste areas and may regenerate prolifically after fire. *Calystegia sepium* is similar to the introduced *Calystegia silvatica* with which it can co-occur.
- In Tasmania, this species has been recorded from riverbanks and the margins of forests in the north of the State around the Tamar region.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
