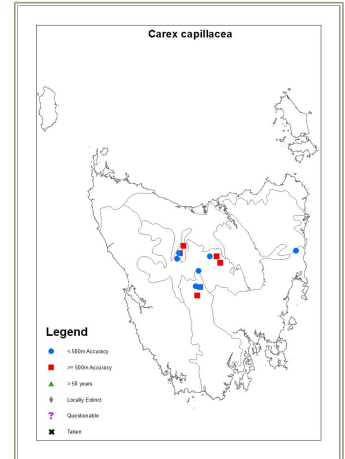

- Flowering of this slender, perennial sedge that forms small dense tufts, occurs in summer (Flora of Victoria). Mature inflorescences are required for identification. Herbarium specimens of this species have been collected from November to February.
- In Tasmania, *Carex capillacea* is found in marshy habitat and short alpine herbfields associated with snow patches around the Central Highlands at altitudes of 600 to 1400 metres.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
