*Carex longebrachiata* drooping sedge

**Group:** Magnoliophyta (flowering plants), Liliopsida (monocots), Cyperales, Cyperaceae

**Status:** *Threatened Species Protection Act 1995*: rare  
*Environment Protection and Biodiversity Conservation Act 1999*: Not listed

**Endemic Status:** Found in Tasmania and elsewhere

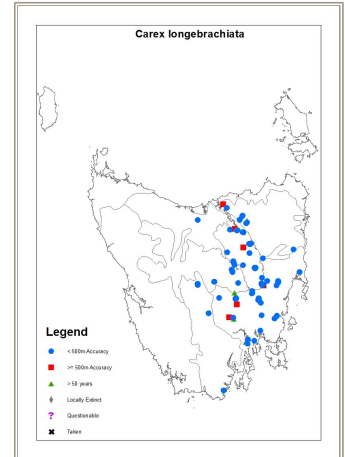

- *Carex longebrachiata* is a robust perennial sedge that forms dense, small to large tussocks. Mature inflorescences are required for identification. Flowering is from spring to summer (Flora of Victoria). Most herbarium specimens have been collected from late October to January.
- *Carex longebrachiata* grows along riverbanks, in rough grassland and pastures.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
