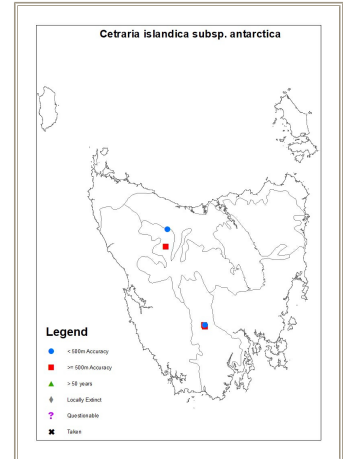

- This distinctive brown fruticose lichen can be identified at any time of the year though expert confirmation of the identity of suspected new populations may be required.
- This species grows over soil and cushion plants in very high alpine moorlands.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
