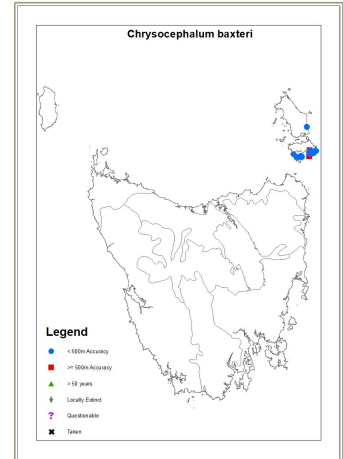

- Flowering of this perennial herb is from spring to summer (Flora of Victoria). Flowers are required for the identification of this species. Most Tasmanian observations have been from late September to December with scattered observations through to April.
- In Tasmania, *Chrysocephalum baxteri* is restricted to the Furneaux Group where it is found on sand dunes between the beach and lagoon, also granite bedrock with some large tors and sandy soils on bare, recently burnt forest.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
