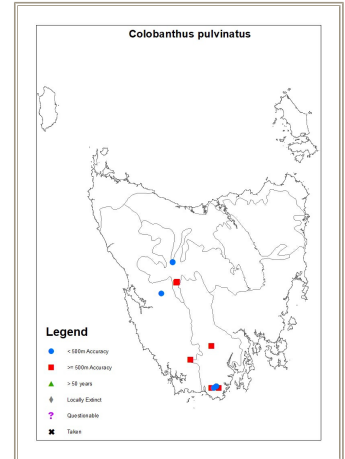

- Herbarium specimens of this compact cushion plant have been collected from late November to March in Tasmania. The detection period may be extended as the species can be identified using leaf characteristics.
- In Tasmania, *Colobanthus pulvinatus* is restricted to fjeldmark on mountains in the centre and south of the State.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
