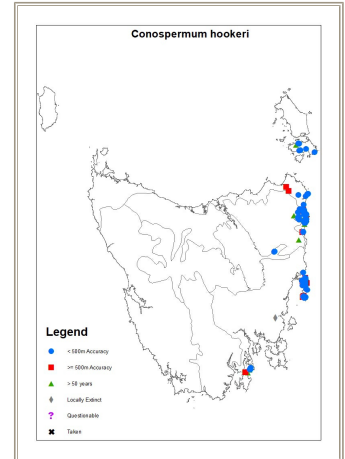

- Conospermum hookeri* is a shrub that typically flowers from September to November with fruit set by early to mid summer. Most herbarium specimens have been collected from September to December though the species can be detected at any time of the year.
- The species usually occurs in coastal heathland and heathy forest/woodland on granite or sandy, acid, low nutrient soils.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
