**Group:** Magnoliophyta (flowering plants), Magnoliopsida (dicots), Rhamnales, Rhamnaceae

**Status:** *Threatened Species Protection Act 1995:* **endangered**  
*Environment Protection and Biodiversity Conservation Act 1999:* Not listed

**Endemic Status:** Found in Tasmania and elsewhere



- This small wiry shrub is most readily recognised when in flower, though its distinctive habit and foliage means that it can be identified at any time of year. The species produces abundant flowers, buds emerging in April and flowering from May to December, with a peak from August to October.
- In Tasmania *Cryptandra amara* grows in some of the driest areas of the State and is typically associated with fertile rocky substrates, its habitat ranging from near-riparian rockplates to grasslands or grassy woodlands.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
