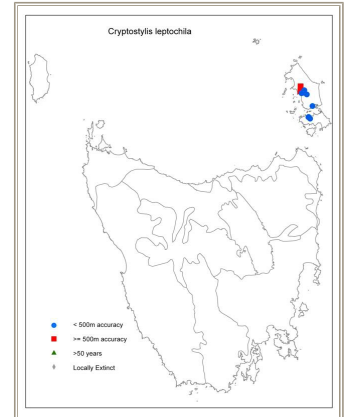

- Cryptostylis* is one of the few evergreen orchid genera in Tasmania and the erect leathery leaves are distinctive, being dark green on the upper surface and purple on the under surface, although difficult to detect amongst dense vegetation. Herbarium specimens of Tasmanian *Cryptostylis leptochila* have been collected in late January to early February.
- In Tasmania (Flinders and Cape Barren islands), *Cryptostylis leptochila* is found in open eucalypt forest with a paperbark and tea-tree shrubby understorey and in heathland on clay loams.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
