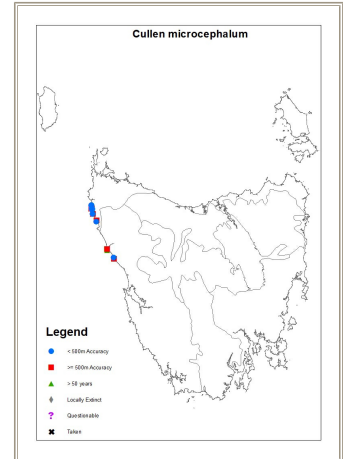

- Flowering of this perennial herb occurs from November to April (Flora of Victoria). Herbarium specimens from Tasmania have been collected from December to January, and observations have been made from late October to March. No other species of *Cullen* occur in Tasmania.
- In Tasmania, *Cullen microcephalum* inhabits well-drained rocky areas and the salt spray zone 100 m from the coast around the west and the north-west.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
