Group: Magnoliophyta (flowering plants), Magnoliopsida (dicots), Solanales, Convolvulaceae

Status: *Threatened Species Protection Act 1995*: rare
Environment Protection and Biodiversity Conservation Act 1999: Not listed

Endemic Status: Found in Tasmania and elsewhere

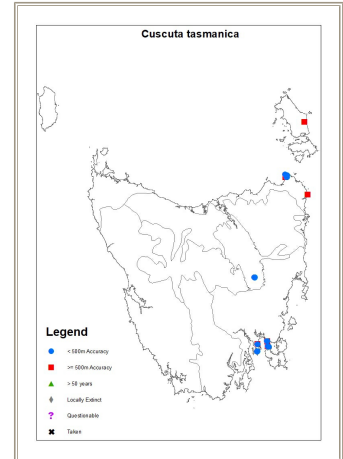

- Flowering of this prostrate perennial parasitic plant is from summer to autumn (Flora of Victoria). Most herbarium specimens from Tasmania have been collected in November and December. While the species can be identified year round, it reduces significantly in winter hampering detection.
- In Tasmania, *Cuscuta tasmanica* is known from saline areas and brackish marshes often, but not exclusively, on plants of *Wilsonia backhousei*.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
