- Surveys for this tall treefern are best undertaken in mid to late summer when identifiable reproductive material is most likely to be present. The plant generally becomes reproductive when it is 1 to 1.5 m tall.
- In Tasmania *Cyathea Xmarcescens* is known from three near-coastal fern gullies in the northeast of the State and on King Island, and from one site in the north of the state.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
