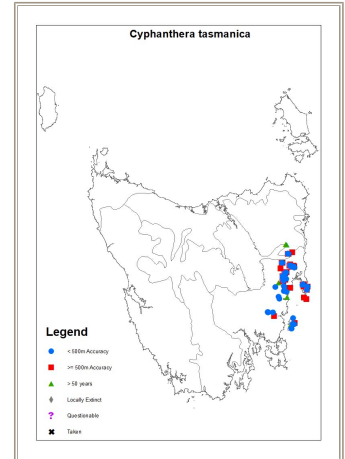

- This short-lived, erect shrub can be identified by its flowers and distinctive foliage. Most observations of this spring flowering species have been made from late October to early February, the recommended survey period, particularly in early years following fire as the species germinates from soil-stored seed in large numbers after fire. Plants may live for about a decade.
- *Cyphanthera tasmanica* is confined to gullies and on hillsides on the East Coast of Tasmania.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
