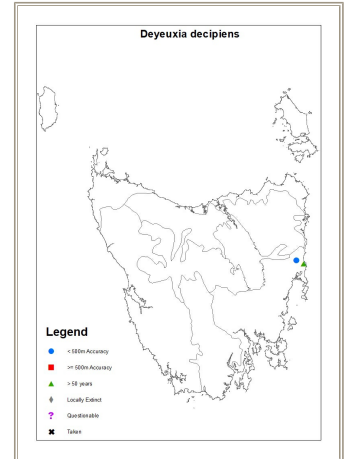

- Mature inflorescences are required to identify this erect, tufted, perennial grass. Flowering is from December to March (Flora of Victoria). Herbarium specimens have been collected in late January and early February.
- In Tasmania, *Deyeuxia decipiens* is found under light forest cover around the central East Coast.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
