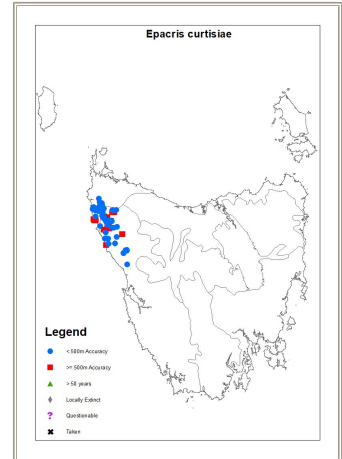

- Flowers aid detection and enable confirmation of the identity of this woody shrub. Flowering is from August to October though herbarium specimens have been collected through most of the year.
- The species occurs in peaty soils or undulating terrain in association with locally common heathlands, graminoid heaths and scrub in the northwest in altitudes below 300 m.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
