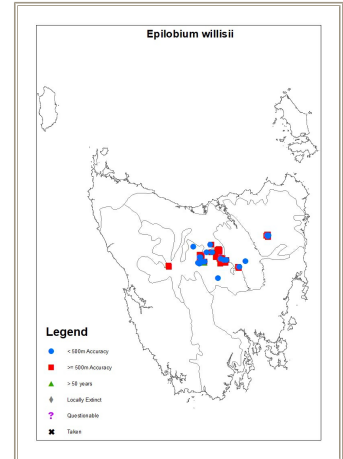

- Flowers and fruits are required to identify this herb. Flowering is predominantly from December to February (Flora of Victoria). Most observations of this species have been made in February and March.
- In Tasmania, *Epilobium willisii* occurs in wet montane herbfields around the central mountains and bare places around the eastern mountains.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
