Euphrasia gibbsiae subsp. *pulvinestr* cushionplant eyebright

Group: Magnoliophyta (flowering plants), Magnoliopsida (dicots), Lamiales, Orobanchaceae

Status: *Threatened Species Protection Act 1995*: rare
Environment Protection and Biodiversity Conservation Act 1999: Not listed

Endemic Status: Found only in Tasmania



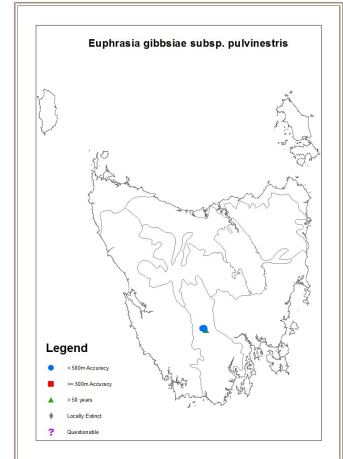

- Flowering plants are required to confirm the identity and aid detection of this herb. Flowering occurs from January to February.
- This species has been predominantly recorded from bolster heath (cushion plant communities) in the Mt Field region and has also been collected from crevices in exposed faces of outcrops in the south-west of Tasmania.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
