Endemic: Found in Tasmania and elsewhere

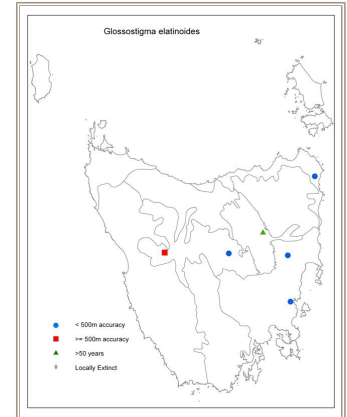

- Flowers are required to confirm the identity of this small, hairless much branched creeping herb. Flowering is from December to May (Flora of Victoria), with most herbarium specimens from Tasmania collected from mid-January to mid-February.
- In Tasmania, *Glossostigma elatinoides* is an aquatic plant that occurs submerged in shallow water and on the banks of streams.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
