Gynatrix pulchella fragrant hempbush

Group: Magnoliophyta (flowering plants), Magnoliopsida (dicots), Malvales, Malvaceae

Status: *Threatened Species Protection Act 1995*: rare
Environment Protection and Biodiversity Conservation Act 1999: Not listed

Endemic Status: Found in Tasmania and elsewhere

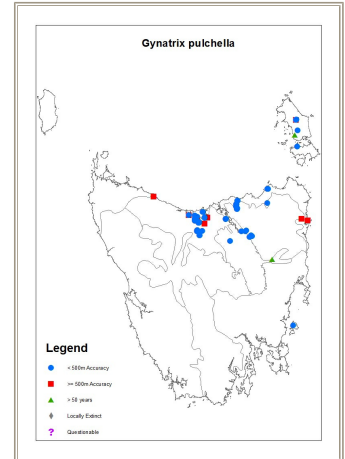

- Although this weedy looking, woody shrub can be detected at any time of the year, female flowers may be needed to confirm its identity. The male and female flowers are borne on different plants. Flowering is from August to October (Flora of Victoria). Most observations of this species in Tasmania have been made from September to December.
- In Tasmania, *Gynatrix pulchella* occurs as a riparian shrub, found along rivers and drainage channels predominantly in the north of the State.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
