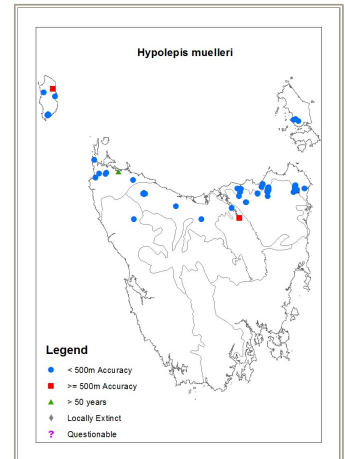

- This terrestrial fern is best identified between December and March using fertile material on its reproductive fronds, though herbarium specimens have been collected through most of the year.
- In Tasmania, this species occurs along watercourses, swampy areas or deep, rich, alluvial soils below 120 m altitude in northern Tasmania including King and Flinders islands. It has also been recorded below a light canopy of *Acacia melanoxylon* (blackwood), *Melaleuca* or *Eucalyptus* species.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
