Group: Lycopodiophyta (fern allies), Isoetopsida, Isoetales, Isoetaceae

Status: *Threatened Species Protection Act 1995*: rare

Endemic: Found in Tasmania and elsewhere

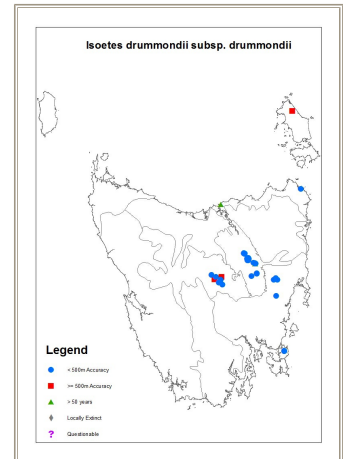

- Most herbarium specimens of this herb-like fern ally have been collected from late November to February. The species can be distinguished from *Isoetes* taxa using vegetative and fruiting characters. The species tends to die back in winter. No other subspecies of *Isoetes drummondii* occur in Tasmania.
- In Tasmania, this semi aquatic species is usually found growing in mud or temporary water and in damp depressions.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
