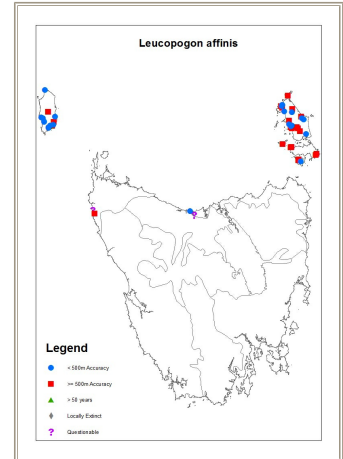

- Flower spikes are required to identify and aid detection of this tall shrub, though mature fruit may be required to distinguish it from *Leucopogon parviflorus*. Peak flowering is from August to October. Herbarium specimens have been collected through most of the year.
- In Tasmania, *Leucopogon affinis* occurs in a broad range of habitats including wet gullies and riverbanks, eucalypt forest on the Bass Strait islands, on stabilised dunes. Observations near Devonport and Latrobe require confirmation.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
