*Levenhookia dubia* hairy stylewort

**Group:** Magnoliophyta (flowering plants), Magnoliopsida (dicots), Campanulales, Styliaceae

**Status:** *Threatened Species Protection Act 1995:* extinct

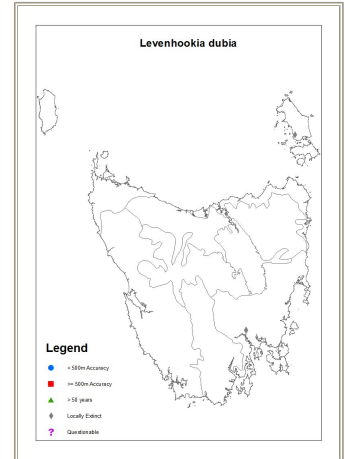

- Flowering plants are required to confirm the identity of this ephemeral herb which is presumed extinct in Tasmania. Flowering is from August to November (Flora of Victoria). On the mainland, this species is only present in years with good rainfall.
- In Tasmania, 19th century collections of *Levenhookia dubia* have been made from Pontville and from Strzelecki Peaks on Flinders Island. Suggested suitable habitat for *Levenhookia dubia* in the State includes moist, often sandy ground in shallow soils on rock ledges.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
