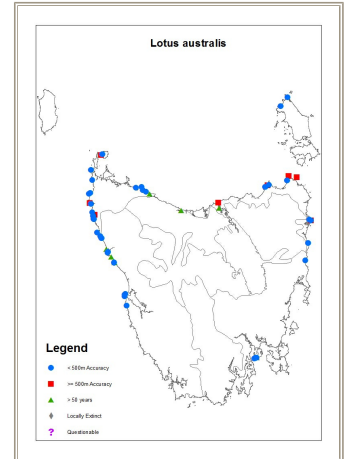

- This erect, perennial herb can be identified at any time of the year by its trifoliate leaves, though its bright pink flowers will greatly assist detection. Flowering is from spring to early autumn. Most herbarium specimens have been collected from November to January.
- In Tasmania, *Lotus australis* is found in coastal areas around the State within *Poa* tussock grassland, low coastal shrubbery and dunes.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
