*Ozothamnus lycopodioides* clubmoss everlastingbush

**Group:** Magnoliophyta (flowering plants), Magnoliopsida (dicots), Asterales, Asteraceae

**Status:** *Threatened Species Protection Act 1995:* rare  
*Environment Protection and Biodiversity Conservation Act 1999:* Not listed

**Endemic:** Found only in Tasmania

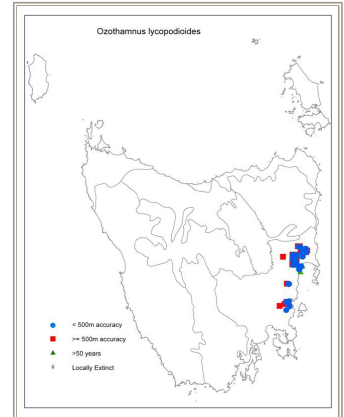

- This slender, much branched, spreading shrub flowers in spring, but can be detected at any time of year due to its distinctive foliage. However, flower head characteristics may be required to confirm that plants belong to the *Ozothamnus* genus.
- Ozothamnus lycopodioides* is restricted to dry sclerophyll forest near the East Coast from Orford to Bicheno where it is restricted to dolerite.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
