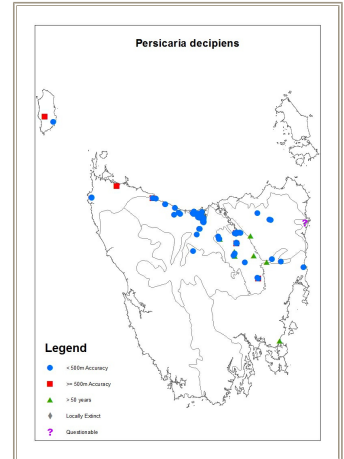

- Flowers are required to confirm the identity and aid detection of this annual or perennial herb which may die back in winter. Flowering is predominantly from December to April (Flora of Victoria).
- In Tasmania, *Persicaria decipiens* occurs on the banks of rivers and streams, mostly in the north of the State, including King Island. The species may colonise farm dams.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
