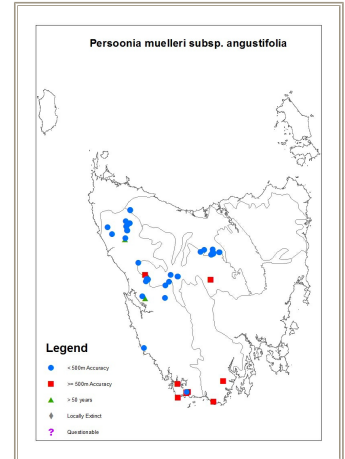

- Flowers are required to confirm the identity of this erect shrub that flowers between December and March though the species can be detected throughout the year. Most herbarium specimens have been collected from December to April.
- This species occurs in central and western Tasmania in rainforest to dense scrub and perhaps, sub-alpine heath in a variety of sedimentary and metamorphic substrata. It typically occurs in the ecotone between dry scrub and rainforest, particularly where high light levels occur on the ground due to a shorter and more open scrub. It is found from 50 to 700 metres altitude.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
