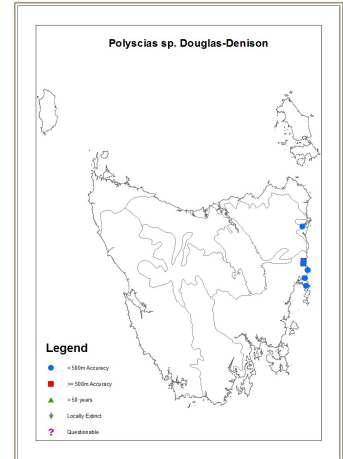

- This small evergreen tree may be identified at any time of year due to its distinctive foliage. The species flowers and fruits sparingly, from about mid-December to February, but does not develop seed.
- Polyscias* sp. Douglas-Denison is restricted to Tasmania's central east coast region between Coles Bay and the Douglas River where it grows in damp shrubby sclerophyll forest with a high dolerite or granite rock cover on steep-sided gullies to more gentle slopes.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
