Endemic: Found only in Tasmania

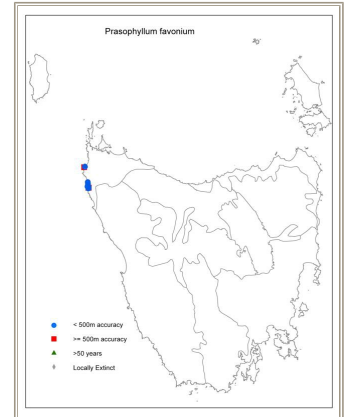

- Flowers are required for the identification and to aid detection of this ground orchid which dies back to subterranean tubers after flowering. Most observations of *Prasophyllum favonium* have been made in early November. As flowering of this species is stimulated by fire, surveys should focus on recently burnt areas.
- Prasophyllum favonium* is restricted to the far north-west of Tasmania where it occurs among shrubs in windswept dense low heathland on moderately drained dark grey to black sandy peaty loam.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
