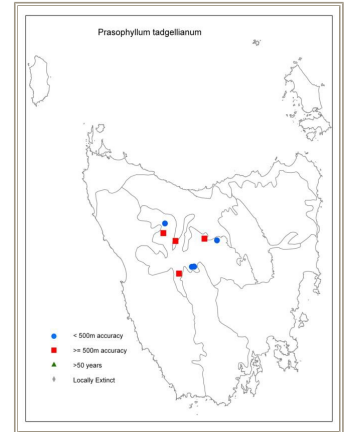

- Flowers are required for the identification and to aid detection of this ground orchid which dies back to subterranean tubers after flowering. Flowering is a month or so later in higher and more exposed sites.
- In Tasmania, *Prasophyllum tadgellianum* occurs on the Central Plateau in subalpine grassland and grassy woodland on well-drained loam, often in moist places near streams and bogs.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
