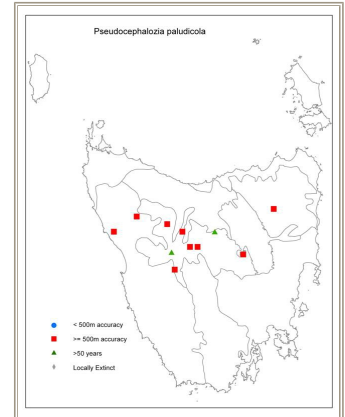

- This erect or nearly erect liverwort can be identified at any time of the year.
- In Tasmania, *Pseudocephalozia paludicola* occurs on wet ground in subalpine grassland in the west of the State and on its central and eastern mountains. Species of *Pseudocephalozia* mostly occur on permanently damp mineral soil or over peat and are frequently found in moorland and sphagnous areas.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
