Status: *Threatened Species Protection Act 1995:* **endangered**

Endemic Status: Found only in Tasmania

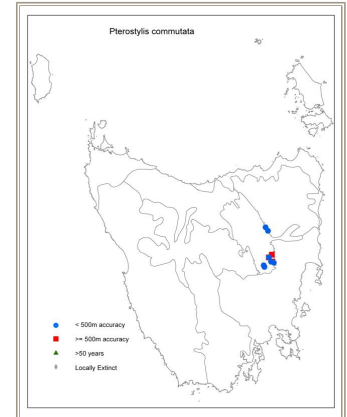

- Flowers are required for the identification and to aid detection of this ground orchid which dies back to subterranean tubers after flowering. *Pterostylis commutata* flowers in midsummer, and is usually in full flower around Christmas time, when the surrounding vegetation has dried off. It occurs in small, loose colonies. The species may not flower or emerge in dry years.
- Pterostylis commutata* is restricted to Tasmania's Midlands, where it occurs in native grassland and *Eucalyptus pauciflora* grassy woodland on well-drained sandy soils and basalt loams.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
