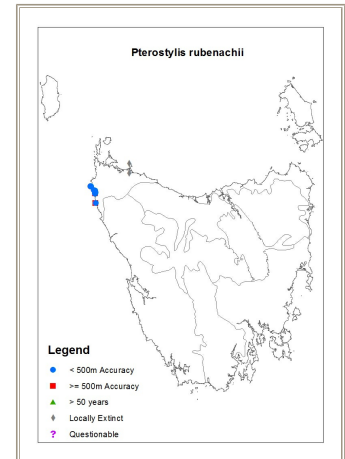

- Flowers are required for the identification and to aid detection of this ground orchid which dies back to subterranean tubers after flowering. Most flowering is in early November.
- Pterostylis rubenachii* is now restricted to coastal lowland along the northern West Coast, where it occurs on dry, sandy slopes of sparsely vegetated stabilised sand dunes, and also in permanently wet to moist scrubby and sedgy coastal heath converted to semi-improved pasture by slashing.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
