Group: Magnoliophyta (flowering plants), Liliopsida (monocots), Orchidales, Orchidaceae

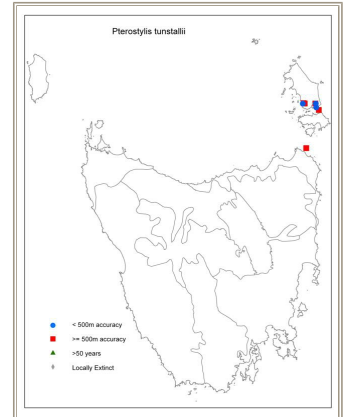

- Flowers are required for the identification of this ground orchid which dies back to subterranean tubers after flowering. Recently fertilised flowers can be dissected and the labellum examined to make an identification. Observations from Tasmania have been made from July to early September.
- In Tasmania (Flinders Island), *Pterostylis tunstallii* occurs in open forest and woodland, often in accumulated litter, on granite-derived gravelly and loamy soils.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
