- This foliose lichen can be identified at any time of the year although expert confirmation of the identity of suspected new populations may be required. This species is presumed extinct in Tasmania.
- In Tasmania, *Punctelia subflava* is known only from a single collection in 1839 from an unspecified location. On mainland Australia, this species occurs in coastal habitats such as mangroves and it is possible that the species once occurred in swampy *Melaleuca* dominated coastal forests in Tasmania.

Permit: A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
